



1. NAME OF THE TRUST:

2. DECLARATION OF THE TRUST:

In Pursuance of the said desire and for carrying out the desire into effect the Authors of the Trust hereby grant, transfer and assign into the Trustees, the said sum of 1000/- (Rupees One thousand only) by way of Corpus and said sum shall vest in the Trustees but upon and subject to the trustees powers and provisions of the Trust Deed, hereinafter declared and expressed. The trust is purely a private Trust.

3. ACCEPTANCE BY TRUSTEES:

For the consideration aforesaid, the Authors of the Trust as Trustees also covenant that the Trustees will stand and be possessed of the said Sum of Rs. 1000/- (Rupees One thousand only) which may under Trust and provision of these presents to be substituted or added in due execution of the Trust and powers of these presents (all of which are hereinafter in these presents designated as the "Trust Fund") upon Trust for uses and subject to the powers, provisions and directions and agreements hereinafter declared and contained in this Deed.



4. PURPOSES OF THE TRUST:

- 2) Without prejudice to the generality of the foregoing objects or purposes that subject to as aforesaid, it is declared that Trustees shall each year apply the income of the Trust Fund and may at their discretion at any time of from time to time apply any one of the following objects or purposes to the exclusion of the other or either of them in such proportion and manner in all respects as the Trustees may in their absolute discretion think proper.
 - i. The board aim is to promote Education & Research oriented Scholarship in the different branches of language, disciplines and faculties.
 - ii. To promote the advancement of studies in all areas of knowledge and disciplines and faculties and also to undertake the work of archive that is collection and protection of manuscripts, books and letters of great authors etc.,
 - iii. To open universities and colleges, schools study centres, residential Educational institutions for the advancement of Higher Education along with Primary Education including teachers training institution, school of nurses all professional courses.





- iv. To open Hospitals and to take up all Health promotion schemes in order to promote the advancement of Higher Medical and also Health Care of mankind.
- v. To open and run Orphanages for Elders and Orphan children.
- vi. To open centers for Temple Architect and construction of temples according to mathematical Agama Sutras.
- vii. To federate with any other Association or International. Organisations having kindred aims and objects to such conditions as are not detrimental to the interests of the Association and its members.
- viii. To run Library/ Libraries and provide excerpts from Books, Documents., Scripts etc. on payments.
- ix. To establish foundations and endowment lectures to spread and promote cause of Educational, Culture, Music, Arts Science, Health, or learning in all branches or all branches or knowledge and wisdom.
- x. To establish and organize Subscriptions, Contributions and Donations to any Public or to the Government or Local Authority, for promotion of any or all of the aforesaid objects.
- xi. To acquire Immovable properties. Land and Buildings, or Construction or Building, for the purpose of accommodating Schools, colleges, Research Centres, Hospitals and for other activities as envisaged earlier.

Xii The surplus and unapplied portion of the income if any arising in any one more year or years shall be accumulated and are invested in accordance with the provisions of the income Tax 1961 as may be in force time to time.

xiii. To federate and affiliate to Universities, Educational institutions, Health organizations and Research Organizations either National or International.


xiv. Feeding of poor children and instituting projects of catering food for poor students undergoing education.

5. TRUST FUND:



Charitable Purpose' in Sec2(5), 10, 11,12, 12a, 12aa, 13, and 80 G of Income Tax Act, 1961 as the trustees may think ft and in such a manner as the Trustees may think for one or more of such Public Charitable purposes as aforesaid to the exclusion of one or more as the Trustees may think fit so as not to violate the provisions of the Income Tax Act, 1961. Provided that the said income as well as the corpus of the Trust Fund shall be applied only towards charitable purposes as aforesaid in India or outside and accumulation of income shall also be made and deemed to be made from application to such charitable purposes aforesaid in India in accordance with the provisions of the Income Tax Act, 1961 the Trust Fund shall be invested in the modes specified Under Section 13 (1) (d) read with Sec. 13 (5) of the Income Tax act, 1961.

6. POWER AND FUNCTION OF THE TRUSTEES:

1. The Authors of the Trust Sri Lokeshwarappa.S shall be the Chairman of the Trust of JNANAVAHINI GELEYARA BALAGA for life with such powers as it is stipulated in the Trust Deed and also with such powers as may be delegated to him from time to time by way of resolution passed by the majority of the trustees: in case the present chairman of the Trust desires to retire or resigns the New Chairman of the Trust shall be appointed by the outgoing Chairman of the Trust in case of Retirement or by majority or remaining Trustees in case of death Chairman of the Trust.



(ii) The Chairman of the Trust of the "JNANAVAHINI GELEYARA BALAGA" shall have the power to open any account in any Bank or Banks without any liability on other Trustees and also to operate the said Bank accounts and be responsible for the acts, deeds or defaults that may occur in connection with such accounts, and also he shall have the power to draw, endorse accept or otherwise deal with cheques, hundles or any negotiable instrument.

- (iii) The Chairman of the Trust of the "JNANAVAHINI GELEYARA BALAGA" shall have power to purchase construct or hire or take on lease any immovable or movable properties for all or any of the purposes of the said trust at such price, costs or rent and on such terms and conditions and for such period and with or without option for renewal as Chairman of the Trust may think fit. In case the immovable property owned by the Settler or any Trustee is taken on lease, rent payable shall not exceed the fair marker rent as assessed by the local authority.
- (iv) The Chairman of the Trust shall have the power to let out, lease sub-lease., mortgage, charge of license any property belonging to the Trust for such rent or compensation and on such terms and conditions for such period as the Chairman of the Trust may deem it.
- (v) The Chairman of the Trust shall have the power to appoint and dismiss and reappoint executive officials, doctors, nurses, clerks, care takers, attendant and other employees on such salary and such terms as he think fit.


(vi) the chairman of the Trust shall have the power to delegate by power of Attorney or otherwise by way of resolution, to any' Trustee or Trustees any other person or persons powers and authorities implied by law conferred by statue or persons, powers and authorizes implied by law conferred by stature or vested in the Chairman of the Trust by these presents. The Chairman of the Trust shall, however not be held liable responsible for the acts or defaults of any such person or persons but on for his own respective acts and defaults.

(vii) The chairman of the Trust shall have the power to reimburse himself or other Trustee or pay and discharge out of the funds or any property subject to the Trust of these present and income thereof, all expenses that may I incurred in or about the expenses that maybe incurred in or about to execution of the Trusts and powers of these presents, including reasonable amount of travelling expenditure incurred for attending any meeting of Trustees.

(viii) The Chairman of the Trust shall have power to decide all question arising in the administration of Trust hereof including all questions relating to the interpretations of these presents, the administration of an institutions maintained by the Trust or concerning any thing or any matt relating to or connected with or arising out of these presents or to operation thereof and the decision of the Chairman of the Trust on all or



any of the matters aforesaid shall be final. The chairman of the Trust shall have the power to appoint any Managing Committee, Sub-Committee, Editorial committee or Advisory Committee and also to nominate Chairman or President of the Trust and to the terminate whenever necessary. The decision of the Chairman of the Trust of the "JNANAVAHINI GELEYARA BALAGA shall be final in all respects irrespective or any other Trustee of Trustees or the majority of the Trustees in the interest of the Trust. If the chairman of the Trust deems fit, the movable or immovable properties, depostis, bank Accounts, and all the belonging including purchase of land of the Trust can be merged with any other Institution or Association having similar objectives, She/he can also also act as Sole Trustee.

(ix) The Chairman of the Trust shall have the power to compromise, compound abandon, submit arbitration or otherwise settle any actions, suits proceedings, debts, claims or things whatsoever arising out of the administration of the Trust Fund, or any Institutions maintained and for any of these purposes may enter in give execute of these and sign agreements, instruments, arrangements, releases and other things as way seem to him expedient, without being liable or responsible for any loss occasioned by act or thing so done by him in good faith a fully as if he was absolutely entitled to the Trust fund and the said institutions without being answerable for any loss occasioned in good faith.



- (x) The Chairman of the Trust shall have the power to frame such rules and regulations for the Management and Administration of Institutions set by the Trust as she/he shall think fit and to alter or vary the same from time to time and to make new rules and regulations, provided that, such rules and regulations shall be in no case be inconsistent with the terms of these presents.
- (xi) The Chairman of the Trust shall have the power to deposit by way of safe custody any documents held by him relating to any property belonging to the Trust with any Bank and to pay any sum payable in respect of such deposit.
- (xii) The Chairman of the Trust shall have the power to borrow or raise any money that may be required by the Trust upon such terms as may be deemed advisable.
- (xiii) Subject to any mandatory provisions of any law for the time being in force and applicable to the trust, the chairman of the trust shall have require investment in any investments or properties of whatsoever nature and where so ever situate and whether involving liabilities or producing income or not or upon personal credit with or without security and in the manner authorized by law for the investment of the Trust Funds and to call in sell, convert or exchange such investments and properties, both movable and immovable whenever She/he, in her/his absolute discretion, things it is desirable to do so.




(xiv) Upon any sale or other transfer by the chairman of the Trust under the powers aforesaid, the purchaser of purchasers, Transferee or Transferees, dealing bonafide, with the Chairman of the Trust, shall not be concerned to see or enquire whether the occasion for executing or exercising such power has arisen or whether the pro visions as to the appointment and retirement of Trustees as to the appointment and retirement of Trustee herein contained have been properly and regularly observed and performed except that the decision to sell the properties has been taken the decision will these presents. Neither shall the purchaser not purchaser, transferees, be concerned to see to the application of the purchase money or other consideration or be answerable for the loss; purchasers shall get a valid title in respect of properties purchased in good faith from the Managing Trustee/ Director.

(XV) The Chairman of the Trust is herby authorized to invite or accept donations of money, shares debentures, bonds, business and other movable or immovable properties, from the settler or any one else by war of gift, grant, legacy or otherwise on such terms and conditions as he may think fit; no being inconsistent with the terms and conditions of these present and such donations shall be held by Chairman of the Trust as accretion to and augmentation of the Trust may Fund Provided that, the Chairman of the Trust may refuse to accept any such donations, grant or legacy which he may in his absolute discretion consider suitable.



(xvi) The Settler of the Trust of Chairman of the Trust shall not be entitled to use of apply any Trust property or Income thereof for their personal benefit in lieu of/ or remuneration of the services rendered or to be rendered or to be rendered by him / her or them in the Trust.

(xvii) The receipt of the Chairman of the Trust for any moneys paid or any stocks, shares & Securities or other investments transfer by him / here event the execution of any of the purposes of the Trust or powers hereof for the purpose of money paid to her / the, shall effectually discharge the person or persons paying or transferring the same there from.

(xviii) The Chairman of the Trust is vested with the power of appointing any person or persons to be Trustee of Trustees of this Trust on permanent basis or for such period as any be specified in the Deed or Deeds appointing the Trustees or Trustees. It shall be lawful for the person or persons for the time being entitled to appoint a new Trustee of Trustees hereof, to appoint any Bank, Company or Corporation to be a Trustee of these presents jointly with the continuing Trustees, upon such terms and conditions or other wise and for such personas the Chairman of the Trust may think fit. There shall be always Two TRUSTEES. On every appointment of Trustee, the trust Fund, Shall, if and so far as the nature of the property and other circumstances shall require or admit and unless the

Trustees otherwise resolve that so as not to prejudice the power of resolve the Chairman of the Trust, be transferred so that the same may be vested in the Trustee or Trustees for the time being. Every Trustee so appointed as aforesaid, may before or after such transfer, act or assist in the execution of the Trust and powers of these presents fully and effectually as if she/ he had been hereby constituted a Trustee. The powers of the Chairman of the Trustees shall be exercised in such a way to achieve the objectives of the Trust.


The Chairman of the Trust shall appoint any person / persons and Trustees of 'JNANAVAHINI GELEYARA BALAGA'
